

## **Terms of Use for surl.li**

### **1. General Provisions**

1.1 These terms apply to all content posted on surl.li and all derivative pages.

1.2 By using the services or tools, the user confirms their agreement with the specified terms.

1.3 Do not misuse the tools. Do not attempt to interfere with their operation, use them in a non-standard way, or hack them. Use the services only for lawful purposes.

1.4 When working with the Services, the user is not granted any intellectual property rights. The terms of use do not give the user the right to use the company's brand for their own personal purposes.

1.5 The Service may contain information uploaded, published, or submitted by third parties. Third parties are solely responsible for this information. The service administration is in no way responsible for the content of the information or the actions of third parties.

### **2. Liability**

2.1 The site administration is not responsible and does not provide any guarantees regarding the functionality of individual services and tools.

2.2 The administration is not responsible for any losses incurred in connection with the use of additional services directly by the user or third parties.

2.3 The user assumes full responsibility for the actions and results obtained in the process of using additional services.

2.4 The site administration is not responsible for any consequences arising from the use of services: lost profits, lost income, loss of data, financial losses, etc.

2.5 The administration reserves the right to change or restrict access to services for users who perform actions that may affect the overall security, performance, or reputation of the site.

2.6 The administration is not responsible for content distributed by third parties through short links created. The user is fully responsible for the content they distribute through the service.

### **3. Prohibited Uses**

3.1 Using the services for the purpose of sending spam, distributing prohibited information, or engaging in any other illegal activity.

3.2 Using the services in automatic mode, in particular using scripts and software, without the prior consent of the parties.

3.3 Use the services if this may lead to any illegal actions or cause harm to anyone: companies, websites, or any network users, etc.

#### **4. Rights**

4.1 The site administration has the right to store and use data obtained in the process of using additional services.

4.2 The administration has the right to use, including publicly, information obtained from the service.

4.3 The administration has the right to terminate activities, make changes, block, or delete the results of the services' operation.

4.4 The administration reserves the right to make changes to these rules without any additional notice. The new version of the rules comes into force from the moment of publication on the website and applies to all users.

- restrict or block the account;
- notify the relevant authorities in accordance with applicable law.

6.4 The user agrees not to create mass redirects that lead to adult content, misinformation, web resources with a questionable reputation, gambling, illegal substances, political propaganda, or manipulation.

6.5 The administration has the right, at its sole discretion, to classify and block links or users who violate these rules without warning.
